Corporate memberships are transferable within Corporation, subject to Board approval of transfer applicant, and payment of a \$50 transfer fee.

## Refund and Resignation

It's agreed and understood that if, for any reason, the Board of Governors does not extend Membership to the Applicant, the Club will refund 100% of the initiation fee deposit made by the Applicant. It is further agreed that the Club may offset any charges incurred for Club services against the initiation fee deposit prior to making any refund.

Applicant may resign from the Club by giving written notice to the Club. The effective date of the resignation will be the date the club received Applicant's written notice. All accrued dues and other charges for which Applicant is liable are due upon the effective date of resignation. Applicant agrees that in the event of a corporate reorganization or personal divorce, this Membership is not divisible and this Membership shall be allocated by agreement of all claimants, or in the absence of agreement, by court order. Such allocations are subject to the sole approval of the Board of Governors. The successor to the membership shall execute all necessary papers and pay all allocation fees required by the Club. Membership does not confer any ownership of the Club's property or assets.

## Payment of Membership Account

Payment of account is due on receipt of the monthly statement. Applicant agrees to pay the account when due. Applicant agrees that the Club may assess a late charge for past-due accounts as provided in the Bylaws of the Club, as amended from time to time. Payments on delinquent accounts apply first to reduce late charges and accrued dues then to food and beverage charges, then to charges. Dues and other Club charges are considered luxuries under all applicable laws. Applicant agrees to pay all reasonable attorney fees, investigator fees and cost in the event this account is turned over for collection. The Membership card shall remain the property of the Club at all times and must be returned to the Club on demand.

# CLASSIFICATIONS OF MEMBERSHIP

### Member Emeritus

Emeritus membership entitles a Member ages 65 or over, who has been a member of the Club for at least 25 years, or any Member aged 70 or over, and spouse to full Club privileges. The initiation fee for Emeritus members is \$150. Membership dues are \$45 per month

### Senior

Senior membership entitles a member aged 39-70, and spouse, to full Club privileges. The initiation fee for Senior member is \$150. Membership dues are \$70 per month.

### Associate

Associate membership entitles a member up to the age of 38, and spouse, to full Club privileges. The initiation fee for Associate member is \$150. Membership dues are \$55 per month.

### Corporate

Corporate membership entitles Corporate designated members and spouses to full Club privileges. Corporate memberships are available only to employees of Corporate Sponsors, and are transferrable within the Corporation. The monthly fee for Corporate Sponsors is \$135. The application fee for each Corporate designated member is \$50. Membership dues are \$30 per month per Corporate designated Member.

### Non-Resident

Non-Resident membership entitles a Member and spouse full Club privileges. However, Non-Resident membership is available only to those individuals whose principal residence and principal business is outside a 30-mile radius of the Club. The initiation fee for a Non-Resident membership is \$150 with dues of \$45 per month.

Membership Classifications, Requirements, & Dues may be changed at the direction of the Board of Governors.
